DOMAIN NAME

TRADEMARK

REGISTRATION

Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. Twenty prints of the mark; and
3. In case of claiming priority, a certified copy of the corresponding home or foreign application of the trademark is required.

- The Power of Attorney must be filed together with the application.
- The POA in the name of same applicant may be used for subsequent filings.
- The Trademark Office will issue temporary filing date and filing number on the same date of submitting the application. The permanent filing number which is the registration number as well and the filing date will be allotted after acceptance of application.

Time frame:

- 1) Rejection: Must be appealed within 30 days
- 2) Opposition Period: There is no provision for opposition
- 3) Filing up to Registration: 2-4 weeks
- 4) Issuance of registration certificate: Within 3 weeks from the registration date

The above time frame is for a normal/smooth processing of a trademark application, in case of no objections by the trademark examiner.

RENEWAL

Filing Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate.

CHANGE OF NAME OR ADDRESS

Filing Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate; and
2. A Certificate of change of name/address, duly legalized up to Lebanese Consulate.

ASSIGNMENT

Filing Requirements:

1. A Power of Attorney, signed by both parties, duly legalized up to Lebanese Consulate;
2. A Deed of Assignment, duly legalized up to Lebanese Consulate; and
3. The certificate of registration of the trademark, or the certificate of renewal registration if the trademark is renewed.

MERGER

Filing Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. A Deed of merger, duly legalized up to Lebanese Consulate; and
3. The certificate of registration of the trademark, or the certificate of renewal registration if the trademark is renewed.

LICENSE

Filing Requirements:

1. A Power of Attorney from the Licensee, duly legalized up to Lebanese Consulate; and
2. A License agreement, duly legalized up to Lebanese Consulate.

PATENT

Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. A Deed of Assignment from the inventor(s), duly legalized up to the Lebanese Consulate;
3. Specifications, claims, abstract and drawings in English together with Arabic translations; and
4. A certified copy of the priority document.

DESIGN

Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. A Deed of Assignment from the designer(s), duly legalized up to the Lebanese Consulate;
3. A certified copy of the priority document;
4. A brief description of the design, pointing out its novel features; and
5. Full description of the drawings and the dimensions thereof.

COPYRIGHT

Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. A Deed of Assignment if the applicant is not the author, duly legalized up to Lebanese Consulate;
3. Five copies of the work; and
4. Full description of the specification of the work.

DOMAIN NAME

Requirements:

1. A Power of Attorney, duly legalized up to Lebanese Consulate;
2. An authorization letter from the applicant to register domain name if the applicant does not have a legal local presence in Lebanon, duly legalized up to Lebanese Consulate; and
3. A copy of the Lebanese Certificate of Registration that should be the same trademark required for the domain name.
