TRADEMARK

REGISTRATION

Requirements:

1. A Power of Attorney simply signed and stamped with corporate seal, indicating the name and title of signatory;
2. Twenty prints of the mark; and
3. A certified copy of the corresponding home or foreign registration, if priority is to be claimed.

- The POA in the name of same applicant may be used for subsequent filings.
- The Power of Attorney could be filed belatedly at an extra cost.

Time frame:

- 1) Opposition Period: 2 months from the publication date
- 2) Total estimated time frame: 9-15 months
The above time frame is for a normal/smooth processing of a trademark application, in case of no objections by the trademark examiner or no oppositions from a third party.

RENEWAL

Filing Requirements:

1. A Power of Attorney simply signed and stamped with corporate seal, indicating the name and title of signatory.

CHANGE OF NAME OR ADDRESS

Filing Requirements:

1. A Power of Attorney simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. Extract from the Commercial Register.

ASSIGNMENT

Filing Requirements:

1. A Power of Attorney from the Assignee simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Deed of Assignment, signed by both parties.

MERGER

Filing Requirements:

1. A Power of Attorney from the entity surviving the merger, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Certificate of merger, duly legalized.

LICENSE

Filing Requirements:

1. A Power of Attorney from the licensee, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A License agreement, duly legalized.

PATENT

Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory;
2. Two copies of specifications, claims, abstract and formal drawings; and
4. A Certified copy of priority document.

CHANGE OF NAME OR ADDRESS

Filing Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. Extract from the Commercial Register.

ASSIGNMENT

Filing Requirements:

1. A Power of Attorney from the Assignee, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Deed of Assignment, duly legalized.

MERGER

Filing Requirements:

1. A Power of Attorney from the entity surviving the merger, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Certified copy of certificate of merger, duly legalized.

LICENSE

Filing Requirements:

1. A Power of Attorney from the Licensee, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A License agreement, duly legalized.

DESIGN

Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory;
2. Three representations of the design;
3. Short description of the design; and
4. Priority document, if priority is claimed.

CHANGE OF NAME OR ADDRESS

Filing Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. Extract from the Commercial Register.

ASSIGNMENT

Filing Requirements:

1. A Power of Attorney from the Assignee, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Deed of Assignment, simply signed and stamped notarized.

MERGER

Filing Requirements:

1. A Power of Attorney from the entity surviving the merger, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A Certified copy of certificate of merger, duly legalized.

COPYRIGHT

Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory; and
2. A copy of the work of art.

DOMAIN NAME

Requirements:

1. A Power of Attorney, simply signed and stamped with corporate seal, indicating the name and title of signatory.
